As more weeds become resistant to Roundup, paraquat's usage continues to increase. Paraquat is sold under various trade names including: Parazone, Para-Shot, Quick Quat, Gramxone, Helmquat, Firestorm, and others.

The National Institutes of Health (NIH) found in a 2011 study that people exposed to paraquat are nearly 2 ½ times more likely to develop Parkinson's Disease. Parkinson's Disease is a disorder of the central nervous system that affects movement, often in the form of tremors, stiffness, or loss of balance.
