As more weeds become resistant to Roundup, paraquat's usage continues to increase. Paraquat is sold under various trade names including: **Parazone, Para-Shot, Quick Quat, Gramxone, Helmquat, Firestorm**, and others.

The National Institutes of Health (NIH) found in a 2011 study that people exposed to paraquat are nearly **2 1/2 times more likely to develop Parkinson's Disease**.
